Spotlight: "Little Green Gas Cans"

Native juniper trees and bushes are a part of our ecosystem. However, they greatly increase the fire risk of your property. Firefighters often refer to ornamental junipers as "little green gas cans". They contain flammable resins and dried vegetation, and when ignited can burn intensely. If you have junipers near your home, consider removing them. You can replace them with fire-wise plants, rock mulches and hard surfaces.
